There are just over 21 school weeks before the trip which equates to a weekly payment of $£ 8.00$ or a monthly one of $£ 27$.

We want every child to join in the visit and do not want finance to be a barrier. We have been given information on 'The Bridge Educational Trust' who may be able to help towards the cost of the trip. 'The Bridge Educational Trust' provides grants each year for educational visits to residents of Dorset and have helped parents from other schools locally in previous years.
